






#### **ERAPerMed – Structure**

\* 32 partners sharing implementation budget for 5 years





#### ERAPerMed – EU co-funded JTC 2018 Scope of the call

TOPIC: RESEARCH PROJECTS ON PERSONALISED MEDICINE – SMART COMBINATION OF PRE-CLINICAL AND CLINICAL RESEARCH WITH DATA AND ICT SOLUTIONS

- Each consortium submitting a proposal, needs to address at least one module out of each major research defined area
- Each proposal should tackle several slots of the value chain (from basic, translational to applied and innovation)
- Patient participation is encouraged

## **ERAPerMed – EU co-funded JTC 2018** Facts and Figures

#### • Pre-proposal stage:

- 159/143 submitted projects
- 741 partners requesting to 30 funding organisations
- 176.21 M € requested funding
- 50 Pre-proposals invited to submit a Full proposal
- 75 evaluators from institutions affiliated to 24 countries (25% females)


# • Full proposal stage:

- 50 submitted projects
- 252 partners requesting to 27 funding organisations
- 59.86 M € requested funding
- 23 evaluators from institutions affiliated to 15 countries





#### **Pre-proposal Coordinators and Partners per Country**




## ERAPerMed – EU co-funded JTC 2018 Pre-proposal Request of Funding per Country




#### ERAPerMed – EU co-funded JTC 2018 Type of Applicant Beneficiary Entity in Pre-proposals





## ERAPerMed – non EU co-funded JTC 2019 Time plan for the development of the call topic

- In 2018:
  - o June: first concept
  - July: Advanced concept based on discussions and decisions taken during the NSC meeting
  - August: First draft of the call text
  - September: Feedback of the CAB /feedback from JTC 2018 PRP upon the concept of 1st JTC
  - October: final version of the call text





## ERAPerMed – non EU co-funded JTC 2019 Scope of the call

#### TOPIC: PERSONALIZED MEDICINE: MULTIDISCIPLINARY RESEARCH TOWARDS IMPLEMENTATION

- Comprises three Research Areas
- Each consortium submitting a proposal must address at least one module of Research Area 3 and at least one module of Research Area 1 or 2
- Proposals must be interdisciplinary and clearly demonstrate the potential impact in Personalized Medicine as well as the added value of transnational collaboration
